### Please note the following:

- 1. One month's deposit is required for new students and for students registering for the next academic school year.
- 2. <u>Non-refundable registration fee: R 8000.00 for new students joining in 2025</u> Once-off payment upon enrolment to secure the student's place at the school.
- 3. Please note that if you choose to pay fees monthly, fees are <u>payable in advance each month</u> <u>in twelve (12) installments</u> via a *mandatory debit order system*.
- 4. Fees are structured annually and parents enter an annual contract with the school.

# Overdue Payments

- 1. Parents and Guardians will be held jointly and severally liable for overdue fees.
- 2. If fees are overdue by one month, the contract is considered to be broken and action will need to be taken accordingly with our policies.
- 3. Students will not be able to access learning and associated activities, including meetings and conferences, until outstanding overdue fees have been settled in full.
- 4. The School reserves the right to not issue student records, transcripts, or diplomas until all accounts have been fully settled.
- 5. Unpaid fees will be referred to legal debt collection. Parents, guardians, and third parties will be liable for the fees plus related costs such as interest and collection charges.
- 6. Where unpaid fees are disputed by a parent/guardian or third party, they shall bear the onus of proving that such amount is not owing or not due to the School.

#### **NWEA MAP Growth Assessments**

MAP assessments, short for "Measures of Academic Progress," are computerized adaptive tests designed to evaluate a student's academic proficiency and growth over time. These assessments are widely used in education to provide educators with valuable insights into a student's current knowledge and learning trajectory. These assessments will be run from Kindergarten (from ages of 5 years old) to Grade 12 at the end of each term.

These assessments are based on the Common Core Standards (CCSS) and are internationally recognized and accredited benchmark assessments.

# **Levies**

### **Aftercare/Supervised Homework**

The school offers supervised homework on Monday, Tuesday and Thursday from the end of school until 15:30 at an additional cost of **R 750.00 per month.** This will run across the school from 2025. Further information will be provided.

# **Additional Programmes**

These are the costs of enrichment programmes that will occur throughout the year. This includes Performing Arts Levies, Service Learning, Tours, Outings, additional clubs and School Events. The costs will be communicated to parents each term.

# **Termination Notice Period**

The Green School requires one *full calendar term's written notice* should the student decide to leave the school. Failure to provide this within the termination notice period will result in school fees for the upcoming/following term. If the school has acted within the parameters and the student has shown academic progress, then a full terms notice is required. The parameters are as follows:

- 1. We will only allow policies, procedures, or behaviors that promote the growth and achievement of students
- 2. All energies will be focused on instructional programs
- 3. We will not tolerate behavior that diminishes the dignity, self-worth or safety of any individual
- 4. TGS will only accept and retain those students for whom there is an existing appropriate educational program
- 5. All decisions will be made based on assuring the school remains fiscally responsible and operates within its own resources
- 6. As a proprietary school, TGS may differ from non-profit institutions in its decision-making processes and its policymaking
